**Minutes of 5 November 2024 Canvass and Provisional Ballot Electoral Board (EB)
Meeting**

The meeting was called to order at 8:03 PM after poll closing. Board members Chuck Haney, Rob DiLorenzo, Lannis Selz, and General Registrar (GR) Patricia Morton were in attendance.

On motion (Selz) and second (DiLorenzo) to delegate authority from the Electoral Board to the General Registrar and Deputy Registrar to open the 1A envelopes, the EB voted 3-0 to approve the delegation.

The Electoral Board then opened and reviewed all of the #2 Envelopes to check for completeness of documentation. This year, the precinct Chiefs were present and participated during the review, and were released immediately upon completion of the review.

Completion of review of all precincts was completed by 9:30 PM. The meeting was recessed until 9:00 AM on Wednesday November 6th.

Review of Provisional Ballots, 6 November 2024

The meeting was reopened at 9:00 AM 6 November 2024 for review of Provisional Ballots, with all EB members and the GR present. One voter was present to review his Provisional Ballot with the EB; the ballot was approved for counting.

One Provisional Ballot was disallowed by unanimous vote for insufficient information (residence and ID information missing).

Upon disposition of the Provisional Ballots, the Canvass continued with review of voter information including Same Day Registrations (SDR) and Write-in votes. No irregularities were found. The Canvass was recessed until Wednesday 13 November 2024 at 9:00 AM to allow time for cross-checking of the SDRs with state databases.

Continuation of Canvass, 13 November 2024

Canvass was reopened at 0900. The EB and GR were all present.

Review of Provisional and CAP-PE ballots continued. All 132 tabulated Provisional Ballots were dispositioned and run through the tabulator for counting. Upon verification, the meeting was recessed at 11:00 until Thursday 14 November 2024.

Continuation of Canvass, 14 November 2024

The Canvass meeting was reconvened at 10:00 AM. All EB and the GR were present.

One final Provisional ballot from a voter on the Appomattox/Charlotte County boundary was correctly dispositioned as being a valid Appomattox ballot. Motion to approve and count the ballot was made by Selz, DiLorenzo second, EB voted 3-0 to approve. Provisional pollbook was signed to finalize that process. At 10:55, Meeting was recessed until Friday 11/15/2024 for signing and sealing of abstracts.

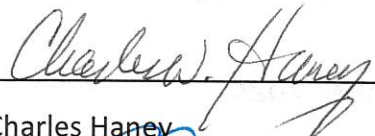
Continuation of Canvass, 15 November 2024

Meeting was reopened at 10:05 AM, with all EB members and the GR present.

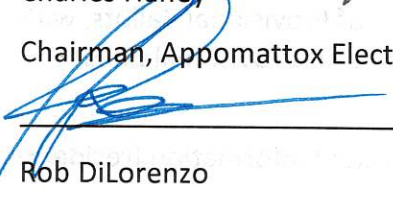
The final Abstract documents were signed and sealed.

It was noted that one of our voting precincts ("Gleaning for the World") was changing its name and we will file the necessary notice to the SBE and the voters.

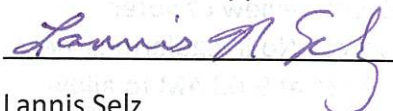
Upon completion of business, the meeting was voted 3-0 to adjourn at 10:45 AM.
