**Minutes of 21 April 2026 Canvass and Provisional Ballot Electoral Board (EB)
Meeting**

The meeting was called to order at 7:24 PM after poll closing. Board members Lannis Selz, Bruce Robertson, Ronnie Haney and General Registrar (GR) Patricia Morton were in attendance.

Upon motion by Lannis Selz, the EB voted 3-0 to delegate opening of the 1A envelopes to the GR and Deputy Registrar (DR).

The Electoral Board then opened and reviewed all of the #2B Envelopes to check for completeness of documentation. The following Precinct Chiefs were present at the meeting and participated during the review of their precinct's materials, and were released immediately upon completion of their individual precinct data review.

Completion of review of all precincts' data was completed by 9:45 PM. The meeting was recessed until 9:00 AM on Wednesday April 22nd.

Review of Provisional Ballots, 22 April 2026

The meeting was reopened at 9:00 AM 22 April 2026 for review of Provisional Ballots, with Chairman Bruce Robertson, vice chair Ronnie Haney, secretary Lannis Selz and the GR present.

No voters were present to discuss their Provisional ballot. Data was noted to be complete on all Provisional ballot envelopes and they were passed on to the GR by a 3-0 vote by the EB for verification of status. The Provisional meeting was closed at 9:15 on a 3-0 vote (motion Robertson).

Continuation of Canvass, 22 April 2026

All EB members and the GR were present. Upon disposition of the Provisional Ballots, the Canvass continued at 9:16 with review of voter information including ballot counts, results sheets, and Same Day Registrations (SDR). OOE's Vicki Canada (Courthouse), and John Redding and Bernadette Servis (CAP) attended the meeting to answer questions about the documentation and complete the signatures required. No irregularities were found in the process. The meeting was recessed on a 3-0 vote (motion Selz) at 1:05 PM until Friday April 24th at 3:30 PM.

Continuation of Canvass, 24 April 2026

Canvass was reopened at 3:30 PM. Lannis Selz, Ronnie Haney, Bruce Robertson and the GR were all present.

Review of Provisional and CAP-PE (Post-Election) ballots continued. The EB voted 3-0 (motion Haney) to reject Provisional ballots that did not have verifiable ID after attempts to contact the voters. The CAP-PE "2B" envelope was opened and the contents reviewed. The CAP pollbook was corrected for one overseas ballot. All returns and reports for all precincts were verified as being complete, correct, and signed. The "2B" envelopes were closed and sealed. The meeting was recessed until 10:00 AM on Monday 27 April 2026.

Continuation of Canvass, 27 April 2026

Meeting was reopened at 10:00 AM, with Bruce Robertson, Ronnie Haney, Lannis Selz and the GR present.

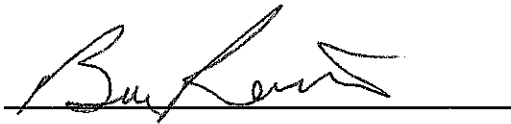
All Provisional ballots were dispositioned. 31 Provisional ballots were received. Six were rejected due to voter ineligibility or lack of verifiable ID. Twenty-five ballots were voted on the Provisional tabulator, and the Zero Tapes, Result Tapes, and the required forms signed by the EB. The results were placed in a 2B envelope and sealed. At 11:50 AM, the meeting was recessed until 3:30 PM the same day.

Continuation of Canvass, 27 April 2026

The meeting was reopened at 3:40 PM 27 April 2026. Final counts were reviewed and sealed.

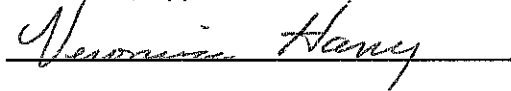
The final Abstract documents were signed and sealed.

Upon completion of EB business for the April 2026 Special Election, the meeting was voted 3-0 to adjourn at 3:58 PM.



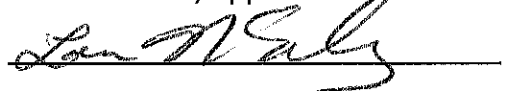
